IAF EXPANDS PROGRAM OPPORTUNITIES WITH CLIMATE AGRI-SOLUTIONS FUND

May 23, 2025, Victoria, BC — The Investment Agriculture Foundation of BC (IAF) is pleased to announce the expansion of the BC Climate Agri-Solutions Fund into a new program, now known as the Climate Agri-Solutions Fund (CAF). Funded by the Government of Canada through Agriculture and Agri-Food Canada's Agricultural Climate Solutions - On-Farm Climate Action Fund, CAF will deliver funding to producers in British Columbia and the Yukon.

In addition to providing farmers with cost-shared funding, CAF will support the adoption of these practices by holding outreach, education and training.
