

IAF HOLDS 29TH ANNUAL GENERAL MEETING

October 1, 2025 – Victoria, BC: The Investment Agriculture Foundation of BC (IAF) held their 29th Annual General Meeting via ZOOM on September 24, 2025, where the Board of Directors shared highlights of IAF's activities and financial statements for the 2024/25 fiscal year.

Three seats for Board of Directors were voted on by delegates of IAF's Member organizations, two Primary Agriculture seats and one Value-Added Food & Beverage Processing seat. Eight candidates put their names forward in advance of the AGM for a seat.

Angela Groothof and Shane Landreville were elected by majority for the Primary Agriculture seats. A majority was not achieved for the Value-Added Food & Beverage Processing seat after two rounds of voting. In accordance with IAF's Bylaws, the Board of Directors who convened the next day for a secret ballot resulting in Lara Tiro as the successful candidate.
